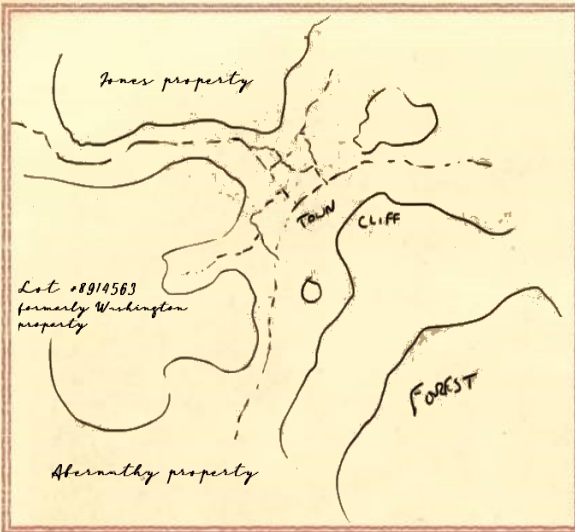


SKETCH MAP DESCRIBING PROPERTY LOCATION.



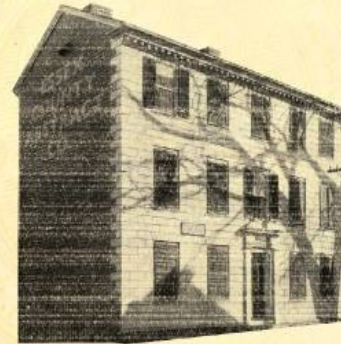
